

**CEMETERY/BURIAL FEES 2015-16**  
**COSTESSEY TOWN CEMETERY, LONGWATER LANE, COSTESSEY**  
**Fees to be charged during the period 01/04/2015 to 31/03/2016**

Fees, payments and sums set out below apply where the deceased person is, or immediately before death was, an inhabitant or elector of the Town of Costessey, or in the case of still-born children, where the parent (or one of them) are such inhabitants or electors.

a) <b>for a casket</b> , in a grave not exceeding 9 feet by 6 feet (2.75 x 1.m), in the section of the cemetery set aside for casket burials ( <b>New price incl extra width</b> )	<b>910</b>
b) <b>for a coffin</b> , in a grave not exceeding 9 feet by 4 feet 6 inches (2.75 x 1.37m)	<b>560</b>
<b><u>PLEASE NOTE:</u> Any burial which requires a wider plot will be charged an additional fee of £16 per extra inch (2.54cm) in a standard plot, &amp; £17 per extra inch in a casket plot</b>	
c) in a grave not exceeding 8 feet by 3 feet (2.44 x 0.9m) for children not exceeding 12 years old in the area of the Cemetery set aside for children	<b>295</b>
d) for the burial of cremated remains in the section of the Cemetery set aside for that purpose	<b>210</b>

**INTERMENTS**

For the interment in a grave in respect of which the exclusive right of burial has been granted:-

a) of the body of a still born child (or children in the same coffin), or of a child whose age at the time of death did not exceed 12 months in the area of the Cemetery set aside for the burial of children	<b>112</b>
b) of the body of a child whose age at the time of death exceeded 12 months but did not exceed 12 years	<b>148</b>
c) of the body of a person whose age at the time of death exceeded 12 years	<b>245</b>
d) of cremated remains in the section of the Cemetery set aside for that purpose	<b>165</b>

**PLEASE NOTE: Children up to the age of 12 years can be buried in the area set aside for children. The definition of a child has been standardised as “not exceeding 12 years”**

## BURIAL WITHOUT THE PURCHASE OF EXCLUSIVE RIGHTS

For the interment in a grave in respect of which no exclusive rights of burial have been granted:-

a) of the body of a still-born child (or children in the same coffin), or of a child whose age at the time of death did not exceed 12 months in the area of the Cemetery set aside for the burial of children	145
b) of the body of a child whose age at the time of death exceeded 12 months, but did not exceed 12 years	280
c) of the body of a person whose age at the time of death exceeded 12 years <b>in a coffin</b> , a minimum of <b>in a casket</b>	540 760
d) of cremated remains in the section of the Cemetery set aside for that purpose	165

## HEADSTONES, TABLETS AND INSCRIPTIONS

For the right to erect or place on a grave in respect of which exclusive rights of burial have been granted:-

a) <b>On a standard plot</b> a headstone not exceeding 3 ft (0.9m) in height & 3ft wide including plinth dimensions.	155
<b>On casket plots</b> a headstone not exceeding 38" high and 3ft wide including plinth	175
b) a cremation tablet not exceeding 1 foot 6 inches (0.45m) by 1 foot 3 inches (0.38m)	102
c) an inscribed vase	102
d) an additional inscription	102

**PLEASE NOTE:** The fees quoted above are for residents of the Town of Costessey. All non-residents will be charged at triple the fees quoted above, except where the deceased person was a resident of Costessey for 20 years or more and has moved from the Town within the last 5 years to recognized sheltered accommodation or residential care **OR** if the interment is into a previously purchased plot, when the Costessey rate applies.
