

## CEMETERY & BURIAL FEES 2024-25

**COSTESSEY TOWN CEMETERY, LONGWATER LANE, COSTESSEY**  
Fees to be charged during the period 01/04/2024 to 31/03/2025

Fees, payments and sums set out below apply where the deceased person is, or immediately before death was, an inhabitant or elector of the Town of Costessey, or in the case of still-born children, where the parent (or one of them) are such inhabitants or electors.

### EXCLUSIVE RIGHTS OF BURIAL (FOR 70 YEARS)

a) <b>Casket plot</b> - grave not exceeding 9 feet by 6 feet (2.75m x 1.83m), in the section of the cemetery set aside for casket burials	<b>950</b>
b) <b>Coffin plot</b> - grave not exceeding 9 feet by 4 feet 6 inches (2.75 x 1.37m)	<b>585</b>
c) <b>Cremation plot</b> in the section of the Cemetery set aside for that purpose	<b>235</b>
d) <b>Burial or Cremation plot – Under 18 years old at time of death</b>	<b>250*</b>

**Please note: An area of the cemetery is set aside for children under 12 years old for a coffin not exceeding 8 feet by 3 feet (2.44 x 0.9m)**

### INTERMENTS

**For the interment in a plot in respect of which the exclusive right of burial has been granted:**

### ASSISTED BURIALS ADMINISTERED BY A BURIAL AUTHORITY (BURIAL WITHOUT THE PURCHASE OF EXCLUSIVE RIGHTS)

### HEADSTONES, TABLETS AND INSCRIPTIONS

For the right to erect or place on a grave in respect of which exclusive rights of burial have been granted:

a) <b>On a standard plot</b> a headstone not exceeding 3 ft (0.9m) in height & 3ft wide including plinth dimensions.	175
b) <b>On casket plots</b> a headstone not exceeding 3ft 2inches high and 3ft wide including plinth.	195
c) <b>On a Child's Plot</b> who was <b>under 18 years</b> old at time of death	<b>NO CHARGE</b>
d) <b>A cremation tablet</b> not exceeding 18 inches (0.45m) by 15 inches (0.38m)	120
e) <b>An inscribed vase</b>	120
f) <b>An additional inscription</b>	120

**PLEASE NOTE:** The fees quoted above are for residents of the Town of Costessey.

Non-residents will be charged at triple the fees quoted above, ***EXCEPT*** where the deceased person was a resident of Costessey for 20 years or more and has moved from the Town within the last 5 years to recognised sheltered accommodation or residential care ***OR*** if the interment is into a previously purchased plot, when the Costessey rate applies.

### GRAVEDIGGER'S FEES:

Costessey Town Council does not employ its own grave digger, so digging fees will be in addition to those quoted above. Arrangements and payment of fees to the Council's authorised grave digger must be via the Funeral Director.
