COSTESSEY TOWN CEMETERY, LONGWATER LANE, COSTESSEY Fees to be charged during the period 01/04/2024 to 31/03/2025

Fees, payments and sums set out below apply where the deceased person is, or immediately before death was, an inhabitant or elector of the Town of Costessey, or in the case of still-born children, where the parent (or one of them) are such inhabitants or electors.

Please note: An area of the cemetery is set aside for children under 12 years old for a coffin not exceeding 8 feet by 3 feet (2.44 x 0.9m)

For the interment in a plot in respect of which the exclusive right of burial has been granted:

a) Body of a person over 18 years old at time of death	270

Re-registering and/or searches - per hour or part thereof

Non-residents will be charged at <u>triple</u> the fees quoted above, <u>EXCEPT</u> where the deceased person was a resident of Costessey for 20 years or more and has moved from the Town within the last 5 years to recognised sheltered accommodation or residential care <u>OR</u> if the interment is into a previously purchased plot, when the Costessey rate applies.
